Licensing Information

Pilot - Aims / Outcomes

Aims:

- Pilot the development of a fixed site alcohol recovery centre in the West End to which the Alternate Response Vehicle (Booze Bus) would bring the patients suffering the effects of alcohol intoxication.
- The Centre would provide patients a safe environment with access to medical expertise and care until they can be suitably discharged home.
- All patients would be offered alcohol advice by trained staff before being discharged.

Outcomes:

- Divert individuals with minor injuries away from A&E thus allowing A&E staff to treat those with most need.
- Reduction in alcohol related hospital admissions (N139 /VSC 26).
- Assist A&E to meet the 4 hour weight, especially at busy times of the year (e.g. winter combined with festive periods).
- Reduction in alcohol related crime and disorder
- Reduction in time Police have to wait for Ambulance staff to arrive on scene
- Improvement of number of emergency calls responded to by LAS in under 8 minutes when centre is open.
- Identify number of problem premises in West End through intelligence gathered from running the alcohol recovery centre.
- Provide value for money.

How it happened operationally

- Pick up spot recorded as per norm on PRF
- Pick up spot was also recorded on Pilot Monitoring Form
- On sobering up, patient were asked to complete questionnaire which included a question on where they had consumed last drink
- Information obtained on premises past to Licensing on weekly basis and local Safer Neighbourhood Team.

Pilot Data

- Total of 268 patients were seen in the recovery centre
- 230 of the patients seen in the centre provided details of where they had last consumed alcohol;
 - *8 had drunk at home
 - 6 drunk outside on the streets
 - 18 couldn't recall the name of establishment
 - \$81 Licensed venues were only mentioned once
 - 29 venues accounted for the remaining 117 Patients

Post Pilot Learning

Feasibility

- Not difficult or workload intensive to obtain information regarding last drink in dedicated environment
- LAS collect some initial data which can be utilised without any substantial increase in workload (intelligence info)
